Our Services

1. Calendar Projects/Events

Our Calendar Projects offer pre-planned, 2+ hour volunteering opportunities on pre-set dates, making it easy for small teams to contribute to ESG and CSRD goals.

- Examples:
 - World Book Day: Assemble literacy kits to inspire children.
 - Earth Day: Community clean-ups to restore local green spaces.
 - Science & Maths Weeks: Build educational kits for schools.
 - Christmas: Craft kits for children in need.
- Details:
 - Pre-scheduled dates throughout the year.
 - Ideal for teams of around 10 volunteers; larger groups welcome for community clean-ups.

Cost: From €880 for kit assembly and €500 for clean-ups (15 volunteers).

2. Team Impact Days

Our Team Impact Days provide tailored, half day and one-day projects for small teams to make a high-impact contribution while meeting your company's sustainability goals.

- Examples:
 - Gardening and painting revamps at schools and community facilities.
 - Assemble kits for schools, homeless services and underserved communities.
 - Create Dementia Memory Collages.
- Details:
 - Kit assembly and Memory Collage projects can take place at your office.
 - Advance planning (4-12 weeks) required.
 - Designed for 15-99 participants.

Costs start at €50+ per volunteer with a minimum of 15 volunteers. Final costs depend on group size, project type and length and if project supplies are required.

3. Large-scale Partner Programmes

Our Large-scale Partner Programme is ideal for companies engaging 100+ employees in local or global volunteering initiatives, designed to align with your goals and community needs.

- Examples:
 - Transform spaces at schools or community centres.
 - Assemble STEM kits, food packs, or festive craft kits.
- Details:
 - Advance planning (3+ months) required.
 - Designed for 100–1,500 participants.

Cost: ~€100 per volunteer for management, plus €50–€60 for supplies.
